LEGAL courses

Corporate Governance has received increasing attention over the last decade. This is partly due to an increased focus on transparency and appropriate governance of organizations and public companies and partly due to specific governance issues such as conflicts between owners and managers, the undefined role of the board of directors, financial scandals, remuneration of management, hostile takeovers, the role of institutional investors, and a need for transparency and accountability in public companies.

The introductory one-day course "International Corporate Governance" takes an international approach to corporate governance with a starting point in continental European governance structures.

Who should attend?

The course is especially aimed at (business) lawyers, fiduciaries, government officials, fund managers, board members, bankers and other people with an interest in International Corporate Govern-

ance. In order to assure and optimal interaction between the course participants, the maximum number of participants is set at 25. Participants are required to be reasonably fluent in English.

Aim of the course

The course aims to give thorough insights in different approaches to corporate governance structures, and an understanding of EU and US regulations on corporate governance issues, various codes of conducts and corporate social responsibility.

The participant will obtain knowledge of various governance models in the large EU countries (including Scandinavia), the US and a selection of Asian countries. Furthermore, the participants are provided with the competences necessary to deal comfortably with the legal/governance issues that may arise in connection to corporate structures in these jurisdictions. In addition, the participants of the course will be able to identify relevant issues in - and sources of - modern corporate governance.
