We thank you for having taken into account our concerns and the questions raised in relation to our colleagues Margaret NG, Martin LEE and Albert HO.


Please be assured that our intervention was in no way intended to call into question the impartiality of your judicial system or that of its officials.

As already noted, the State of Hong Kong has subscribed to a number of international commitments, including the International Covenant on Civil and Political Rights (ICCPR) and the 1990 UN Basic Principles on the Role of Lawyers, as a normative under customary international law. As an association representing, inter alia, the interests of lawyers worldwide, it is also our mission to draw the attention of the competent authorities of the States concerned to situations such as the one in the present case, in order to ensure that the rights of our colleagues to freely exercise their profession, including legitimate human rights actions, are respected in accordance with the laws in force.

We can only welcome the values of respect for the rule of law, transparency and independence of the judicial system as well as equality between all citizens that you reaffirm in your letter with strength and conviction.

We thank you for your attention and will respectfully continue to closely monitor the present case and any other situation involving human rights lawyers exercising their profession with conviction, courage and respect for the law.
